Provides free dental services and dental health education for disadvantaged youth. The program served the Alvord Unified School District, Jurupa Unified School District, and the Riverside Unified School District. It has educated over 31,000 youth in the city of Riverside, CA.

4b (Code:) (Expenses \$ **395,000** including grants of \$) (Revenue \$)**Community Outreach & Chronic Disease Prevention Program:**

Promotes healthier behaviors and choices within the community with exercise classes, nutrition and cooking classes, and workshops. Other classes range from the dangers of substance use to self-defense workshops.

The organization collaborates with the Riverside Chronic Disease Collaborative (RCDC). Through this collaborative effort, the organization strengthens community programs and services for the prevention and management of diabetes in Riverside. They enhance Riverside's capacity to effectively decrease the onset of new diabetes cases and the long-term complications of the disease. Over 21,000 have been served.

4c (Code:) (Expenses \$ **473,559** including grants of \$) (Revenue \$)**Eastside HEAL Zone:**

The Eastside HEAL (Healthy Eating, Active Living) Zone (EHZ) is one of several Kaiser funded HEAL initiatives in California. It exists to promote a culture of health, hope, unity and leadership in Eastside, Riverside. The EHZ team collaborates with other entities to empower adult and youth residents through leadership programs and assists residents in making lasting changes in their community through resident-driven community improvement projects. Youth and adult residents have led many community improvement projects, which have impacted the health and safety in their environment. Over 2,800 served.
